## INTERNSHIP IN HEALTH CENTERS

### GENERAL DESCRIPTION AND CONTENTS

The Health Centers Internship Program at the Modern Languages Center of the University of Granada was launched in the 2012-2013 academic year. This program is aimed at university students and professionals interested in expanding their studies through health internships.

It began thanks to the agreement signed with HLA Inmaculada Grupo Hospitalitario.

The implementation of these Internships is aimed at:

- CEH students (Level 7 and higher)
- CILE students (Level 7 and higher)
- CILYC students (Level 7 and higher)

Equivalent to a 45/120 hour subject, organized as follows:

- Joint seminar: 10 hours
- Individual interviews with the CLM Internship Coordinator: 2 interviews lasting 1 hour each
- Joint seminar or follow-up: 2 hours
- Internship in a hospital: 45/120 hours
- Preparation of final report
- Presentation and evaluation of reports

To have the right to be evaluated, attendance at tutorials with the CLM tutor is mandatory.

The final grade will be composed as follows:

- Students' attention, participation and attendance at joint seminars and individual interviews will be valued with 20% of the final grade.
- 50% of the final grade will be obtained through the report that the external tutor will issue on the work carried out at the health center.
- The remaining 30% will depend on the results obtained in the report that students must present in writing and orally at the end of the course.

### ORGANIZATION

Before starting the internship at the hospital, students attend 10 hours of seminar given by the CLM Internship Coordinator. In these seminars, they students are introduced to:

- The Spanish health system in general
- Types of health centers

- Specific vocabulary that they will need during the internship

Once the seminars are over, the students will be accompanied by the CLM Internship Coordinator to visit the hospital for the first time. In the first meeting, they are received by the Health Center Director, part of the medical team and the doctor-tutor who will oversee them during their internship period. They are then given a guided tour of the hospital to show them the different areas of specialization, facilities and other services. They are informed of their schedule and are given precise instructions as to what they should do on their first day, who they should contact and where they can get their gown and identification card that they must wear during their stay in the hospital.

## OBJECTIVES AND RESPONSIBILITIES

---

The objectives pursued with these practices are:

- That the students know the operation of a Spanish health center
- That they benefit from interaction with professional health teams
- Contribute to training professionals to have adequate knowledge of health sciences
- Ensure that professionals carry out activities aimed at promoting, maintaining and recovering health

The functions performed by the students are to accompany and observe the following specialties:

1. Emergency Room: knowledge of medical history, emergency examination, complementary tests, organization of the service, etc.
2. Pediatrics: neonatal area, outpatient consultation and room pass in the morning.
3. Physiotherapy: area of rehabilitation, exploration and observation of different cases.
4. Internal Medicine: external consultation, room pass, specialty consultation (only for those who do 120 hours and can do the practices in the morning shift)
5. Nursing Area: observation and support of the nursing team in the Emergency Department.

## REQUIREMENTS

---

To participate in these practices, the following are essential requirements:

1. Provide a negative Criminal and Sexual Offense Background Check from the student's country of origin with the Hague Apostille Seal. In the case of the United States, this means that this certificate must be issued by the FBI.



## REQUIREMENTS

---

2. To be part of this program, the student is required to have a level of knowledge of Spanish that qualifies them to adequately carry out their functions in the assigned company (have passed level B2.1).
3. It is advisable to leave one or both of the morning shift time slot free (Monday-Wednesday and/or Tuesday-Thursday from 9:00 a.m. to 2:00 p.m. respectively).
